the upper part of Woodward Drive will be replaced with an end of main line clean-out on segment WB-18. The end of main line manhole will be relocated to coincide with a customer's service pipe—thus, avoiding excavating near an existing hillside slip. The actual cost of this Work Change Directive will be reconciled in a future Change Order.

Consider for approval, and authorize the CSB General Manager, or his designee, to effect the award of a purchase contract to Ques, Inc. of Orlando, Florida, the only responsible bidder, for a new camera van, crawler and inspection system, in the amount of \$189,910.00. This camera van, crawler and inspection system replaces CSB Maintenance Department's Unit No. 86 (2006 model). CSB FYE21 capital budget for this item is \$210,000.00.
